**Motion: (Kenney) To raise the late fee to \$30 for athletes that register after noon on the day before the event. Stone seconded. Favor – 4, Opposed – 5, abstentions – 3. Motion fails.**

**Motion: (Stone) To change the placement of the morning of the event registrants from the start of the run order to the end of the run order. Holmes Seconded. In Favor – 6, Opposed – 4, Abstentions – 2. Motion carries.**

13. EQS/Development - Suzi Preston

- Result of Suzi contacting all EQS organizers prior to event this season
- USSA has refused to score youth licenses based upon company policy.
- EQS Big Air events will be scored at 100 points this season, as they were scored incorrectly last season.

**Motion (Newson): Discontinue the use of the Eastern Points List and use USSA's FSP list . Titus seconded. In Favor – 2, Opposed – 9. Motion fails.**

This was our plan last spring.

Motion (Newson): EQS competitors wishing to be ranked on the FSP for the purposes of qualifying to Regional finals and EQS Championships must have a USSA competitor's license. **Motion withdrawn.**

Motion (Newson): The EQS Regional Finals' invitations will be determined from List #3 which closes Feb. 10<sup>th</sup>, 2004. **Motion withdrawn.** This will take Regionals and the last couple of EQS events of the regular season out of the equation when determining Regional Finals invitations, but all of these events will, in fact, be utilized by using List #4 for figuring EQS Championship invitations.

Motion (Newson): The EQS Championship invitations will be determined from List #4 which closes on Mar. 2<sup>nd</sup>, 2004 and will include the Regional Finals wild card recipients. **Motion withdrawn.**  
Wild Card definition: A wild card is just that – it is an extra spot awarded to the qualifying athlete above and beyond any regular invitation to EQS Championships. This athlete need not have the minimum number of events (three) in order to qualify for this wild card spot.

Motion (Newson): EQS skiers must declare their own individual regional association at their first meet for the purposes of determining invitations to the Regional Finals. This regional association may be altered by notifying the EFCC Chair. (See Deb's Report #2 attached.) **Motion withdrawn.**

The Eastern office will continuously update their database with regional declarations, thereby making it easy to generate the Regional invitations from the FSP.

**Motion: (Preston) For the purposes of Regional Finals, mountains/programs/athletes will only be invited to their respective Regional Finals:**

**Central Region: Vermont - Stowe, Sugarbush, Killington, Okemo, Mt. Snow, Stratton, and Bromley.**

**Eastern Region: Maine, NH, MA, CT, RI - Sugarloaf, Sunday River, Waterville Valley, Loon, Attitash Bear Peak, Mt. Sunapee Resort, Wachusett Mt.**

**Western Region: Bristol, Buffalo Ski Club, Holimont, Hunter, Lake Placid, Holiday Valley, Ski Windham.**

**Nick seconded. 10 in favor, 0 opposed, and 1 abstention. Motion carries.**

**PREVIOUS MEETING**

Committee members in attendance – Suzi Preston, John Spottiswoode, Steve Kenney, Glenn Eddy, Larry Titus, Deb Newson, Joan Dolan, Jay Lauder, Dick Holmes, Michael Macomber.

Meeting was called to order at 9:00 am. A quorum was established.

Motion: Deb Newson and seconded by Glenn Eddy to accept the Spring EFCC minutes.

Vote: All in Favor. Motion passes unanimously.

**CHAIR REPORT:** (Deb Newson)

**National Meeting Report** – Deb Newson/Rich Hilliman – There is an on-going freestyle community symposium to improve number of members in USSA. There’s a move to really build the base of freestyle through multi-sporting – so that athletes won’t need to choose so early on. Specifically for freestyle we have clarified what “Development” means to us as a community by breaking this word into two. We will refer to any competitive mogul skiers as the *performance* side of “Development”, and we will refer to younger members or members who do not wish to attempt to move up the traditional competitive pipeline

as the *participant* side. A Club survey and a Member survey will be coming out from USSA in the middle of November to determine how USSA can better serve clubs and members. There was some discussion at the EFCC meeting about adding a mogul series in the east for eastern participants not on the performance track. We will continue to investigate this possibility until USSA provides us with more information.

#### **USSA Rules and Technical Sub-Committee Report:**

1. At the FSC meeting we put into effect "Big Air" event which includes aerials (jump must be called prior to start, inverted aerials and events where degree of difficulty is factored in ) and big air 4600 (no degree of difficulty factored in) besides our inverted aerial events, we will only host big air events in the East.
2. Adopted the FIS rule that no more than 2 twisters will be allowed during a mogul jump.
3. Increased the aerial quota to 60 per sex at the Junior Olympics which will allow seniors to be included at the Jr. Olympics.
4. All mogul skiers are required to wear helmets during official training and competitions at USSA events.

New EQS radios have not been purchased but will be purchased soon.

There are several outstanding head taxes.

Motion: Deb Newson and seconded by Jay Lauder: That we collect funds prior to November 1<sup>st</sup> from these areas. If funds are not collected by then, ski areas competitions will be cancelled.

Motion was withdrawn. However, the eastern office will look to collect all funds ASAP.

Promotion and sponsorship is no longer a board position. The chair will be taking care of it. Nate McKenzie, CVA Head Freeride coach is working hard on getting sponsorship for the big air events. Deb will dust off the sponsorship sheets and e.mail them to people.

#### **VICE-CHAIR REPORT:** (Larry Titus)

USSA Eastern Online Registration will change to a single form per event. Registration for each event will automatically close on Monday night before event instead of Friday one week prior. Downloads will be available for events without any need for edit. Schedule changes only affect single form. There will be a required entry for each day (must pick an event or none). Multi event days prevent duplicate entry. Payments to event sent with registration list. There will be a link from the eastfree schedule to a registration form for each event. Larry has been working primarily with active.com to try to implement these changes for the upcoming season.

Motion: Glenn Eddy seconded by Larry Titus. The selection committee will determine whether an athlete that cannot compete in the divisional championships remains on the points list. (Selection Committee – Chairman: Dick Holmes, Steve Kenney and Jay Lauder) 7 approve, 2 abstentions. Motion carries.

#### **RULES AND TECHNICAL REPORT:** (Jay Lauder)

The new TD Report Card was passed out at the meeting which needs to be discussed with the TD's prior to adoption. We will use the report card as a working document this year.

At a meeting on Friday, 9/27/02 there was a small TD meeting where various TD concerns and how to run a meet issues were discussed:

- a. TD's were recommended to take digital photos of good courses and bad courses to share with meet organizers
- b. At B level events it was suggested that awards should be trophies rather than ribbons.
- c. Not having 2 runs at B events is a big problem – we should try to figure out how to fix this.

Motion: Jay Lauder seconded by Steve Kenney. At "B" events all award ceremonies will begin 15 minutes after the scores are certified.

Motion withdrawn.

TD clinic here at Killington tomorrow. Expecting a good turnout.

Motion: Jay Lauder, Seconded by Steve Kenney. Pay TD's at "B" meets in accordance with our current official pay scale. 4 in favor, 3 opposed, 2 abstaining. Motion carries.

**SELECTION REPORT:** (Dick Holmes)

End of season move-ups were distributed at the spring meeting. They are available at eastfree.org. "B" meet scores must be submitted by Monday morning at 8am.

Motion: Dick Holmes seconded by Suzi Preston. Eliminate the automatic mid-season move-up and replace it with an appeal process to the selection committee by the athlete or the coach for J4's.

Vote: All in favor. Motion passes unanimously.

The national points list parallels the eastern points list very closely.

**CALENDAR REPORT:** (Joan Dolan)

The schedule is fairly complete. A couple of "B" events and an A/B meet at Bristol TBD. Sanction agreements were sent out 2 weeks ago to meet organizers, which are due back to me by October 15<sup>th</sup>, to allow time for corrections and to be sent to USSA. Deb will provide the Nor/Am and National Competition Schedule after lunch.

Long time freestyle competitor and coach Greg Francoeur passed away unexpectedly in late August. He leaves behind his wife, Sue and 2 small children, ages 2 and 4. His family has established a memorial scholarship to be given to a weekend freestyle competitor who aspires to attend Carrabassett Valley Academy. Donations to the scholarship fund may be made to the Greg Francoeur Memorial Scholarship Fund, 179 Bruce Hill Rd. Cumberland, ME.

Sugarloaf's December mogul competition will now be called the Greg Francoeur Memorial.

Presentation of Bristol A/B event proposal discussion. The committee approved that Bristol hold an A meet on the same weekend as their B meet.

The central (Chairman - Steve Kenney) and western regions (Chairman - Mark DePeters) will create and provide to Joan a regional championship rotation through 2009 prior to the spring meeting. The Eastern Regional Championship rotation is already established.

**COACHES REPORT:** (Glenn Eddy)

Coaches education developments – this spring beginning on May 2 at Mt. Bachelor in Oregon there will be a level 3 freestyle coaches academy in conjunction with the Alpine Coaches Academy. Fall clinics in the East – Level I clinics are now generic for all disciplines programs with ACEP and on snow parts. October for off snow clinics and throughout the winter for on snow clinics. There is no level 2 clinic scheduled in the east this winter, perhaps there can be one organized for either November at Sunday River or somewhere in the spring. There is an acute freestyle coaching shortage, not sure what to do about it. Nick Preston has been nominated as USSA's USOC Development Coach of the Year. He is one of 5 finalists, and the decision will be made on October 16<sup>th</sup>.

**EQS REPORT:** (Suzi Preston)

Regional championships worked well last year – provided more opportunities for competitors to participate in championship level events. Communicated changes in numbers that were approved in the spring for EQS Championships– 90 in the moguls – 72 from the points list and 6 from each of the 3 regions, 2 girls and 4 boys, 70 in big air – 52 from the points list and 6 from each of the 3 regions, 2 girls and 4 boys.

Motion: Joan Dolan seconded by Jay Lauder. All J3's may choose to ski at the A or the B level. 6 in favor, 2 opposed, 1 abstention. Motion carries.

Motion: Steve Kenney seconded by Dick Holmes. All competition programs or individual athletes must elect their associated region before February 1st and notify the Eastern Chairperson in order to qualify for regional championships. Motion passes unanimously.

Motion: Steve Kenney seconded by Suzi Preston. The list for the EQS divisional championships will be run after the regional championships so as to include regional championships. Motion passes unanimously.

**NEW SCHOOL REPORT:** (Suzi Preston for Nick Preston)

There are 44 athletes training at Lake Placid this weekend on the water ramps. They will keep the ramps open as much as possible

A half-pipe event will be fielded at the Junior Olympics – we need to host at least 2 half pipe events prior to the selection event. Please contact Joan Dolan if you're interested in hosting an event.

Rich Hilliman provided some 2001-2002 US SKI TEAM mogul tapes from the World Cup Events.

**OPERATIONS REPORT:** (Deb Newson for Dick Stone)

Dick held a scoring clinic in Utah last weekend, and has made some good changes to the winfree program for the upcoming year. Larry Titus will be taking over Dick's duties in relationship to the registration program.

**JUDGES REPORT:** (John Spottiswoode)

There will be an October 27<sup>th</sup> judges clinic in Lake Placid, New York in conjunction with the FIS clinic.

Motion: Deb Newson seconded by Larry Titus. People who participate in a 1 day judges clinic may judge a B level event as a volunteer provided there is at least one certified judge at the event.

8 in favor, 1 abstention. Motion carries.

**OLD BUSINESS:**

Motion: Larry Titus seconded by Jay Lauder. For championship events, selection will be made from competitors meeting the minimum event participation requirement unless the quota is not met at which time selection to championships may include single event participants. 9 in favor. Motion passed unanimously.

Motion: Jay Lauder seconded by Mike Macomber. A mountain hosting a "B" level event can elect to use a volunteer TD if the volunteer TD is from outside of the hosting mountain/clubs and is qualified by the present policies and rules. All mountains/clubs using this option must contact the R&T Chairman, Jay Lauder, with the name of the individual by December 1<sup>st</sup> of the competition year. Mountains/clubs that do not provide a volunteer TD will incur an additional \$2.00 to their existing Eastern Head Tax to cover the paid TD.
